#### E Terms and definitions

For the purpose of this procedure, the terms and definitions provided in FSC-STD-01-002 FSC Glossary of terms, FSC-PRO-06-002 The Development and approval of FSC National Risk Assessments and FSC-STD-40-005 Requirements for Sourcing FSC Controlled Wood apply.

#### 1 Document flow

- 1.1 An NRA approved according to *FSC-PRO-60-002 V2-0* ('old NRA') remains valid until replaced by an FSC risk assessment approved according to *FSC-PRO-60-002 V3-0*, but no longer than until 30 June 2019.
- NOTE: National risk assessments approved according to version 2-0 of FSC-PRO-60-002 are listed in Annex A of this procedure addendum.
- 1.2 If an 'old NRA' is not replaced by the FSC risk assessment approved according to *FSC-PRO-60-002 V3-0* by 30 June 2019, the area covered in the 'old NRA' becomes unassessed area. Organizations sourcing material from this area will be required to develop extended company risk assessments (ECRA) instead.
- 1.3 Approved FSC risk assessments are available on the FSC document center (<u>https://ic.fsc.org/en/document-center</u>).
