## Instructions for using this form:

1. Save this PDF on your computer and ensure it is open in Adobe Reader (<u>click here to download Adobe Reader</u> if you do not already have it).

**Note:** The form will not function properly if opened in anything other than Adobe Reader. Therefore, please ensure the form is not open in a window of your internet browser or another program when you do the following steps.

- 2. Fill in the document code. Ensure the correct version number is included. Forms missing this information will not be processed.
- 3. Use a new request number for each complaint, dispute, or change request. This means if you have multiple issues with the same indicator, you will repeat the same indicator on multiple lines.
- 4. Choose which section or indicator is the subject of your complaint, dispute, or change request from the dropdown menu in the column titled "Section or indicator".
- Describe your complaint, dispute, or change request related to the corresponding section or indicator.
- 6. Provide evidence supporting your complaint, dispute, or change request. Publicly available information is preferred, but personal knowledge or experience will be considered as well. Evidence is required for consideration of the change request.

**Note:** You are not limited to the space shown on the fields. They will scroll as you type or paste text you typed in a word processor.

7. Push the "Submit Form" button and follow the on-screen instructions.

- 8. Save the filled-in form on your computer.
- 9. Attach the saved form to an email with the subject "change request for [document code]".
- 10. Send the email with the filled-in form and any other attachments to controlledwood@fsc.org.
