SYNERGIES WITH THE GBF

FSC solutions are formally recognized in the GBF monitoring framework as follows:

- Target 10 Classified as a component indicator to measure area of SFM- same as SDG15
 - "Area of forest under sustainable management: total forest management certification by the Forest Stewardship Council...".
- Goal B classified as a complementary indicator "Number of certified forest areas under sustainable management with verified impacts on biodiversity conservation".
- FSC Solutions actively support many other targets, in particular Target 15- corporate disclosure and Target 16- enabling sustainable consumption and Target 19- mobilizing finance.

GENERATING ECOSYSTEM SERVICES CLAIMS

These claims help forest managers communicate the positive impact of their responsible forest stewardship. The claims procedure enables forest managers to measure and verify the impact of their responsible forestry on biodiversity, carbon storage, and more.

SPONSORING ECOSYSTEM **SERVICES CLAIMS**

Corporations and others can sponsor responsible forestry projects around the globe that address climate change, biodiversity loss, and other challenges. In return they receive verified, third-party evidence that their investments made a real and measurable impact.
